### School Closures:

- **Public Holidays:** Columbus Day, Veteran's Day, Thanksgiving + the day after, MLK Day, President's Day, Memorial Day, Independence Day
- **School Breaks:** Holiday Break (*From Christmas to New Year's*)
- **Inclement Weather/ Natural Disasters:** We may close for extreme weather or other emergencies or state mandated shut-downs. We will keep families notified via the EDUCA Dashboard. **There are no tuition credits for these closures.**

**GENERAL** Your tuition is calculated annually. You have the option of paying it off either monthly or weekly \_\_\_\_\_

**TUITION INVOICE** Your annual invoice will be created in week one of your enrollment and emailed to you. Your preferred email address:

**PAYMENT DUE DATE** Payments are due on this invoice **monthly** on the first day of attendance each month \_\_\_\_\_

**PAYMENT TYPE** Payments may be made at the school with cash, check, and money order, or online directly from the link in the invoice \_\_\_\_\_

**LATE PAYMENT FEE** 1.5% fee will be added to balance due if payment is more than 5 days past the payment date \_\_\_\_\_

**OUTSTANDING TUITION** Failure to pay tuition for two consecutive weeks will result in your account and enrollment being put on hold until the balance has been paid. We are happy to discuss payment options with you \_\_\_\_\_

**RETURNED CHECKS** The full Returned Check Fee levied by the bank will be added to your account. Subsequent payments must then be made with cash, money order, or online \_\_\_\_\_

**ADDITIONAL FEES** Lunch Bunch or Late-Night fees will be added to your invoice on a monthly basis based on your child's participation \_\_\_\_\_

**EARLY WITHDRAWAL** If you choose to withdraw prior to the end of your enrollment term you are required to give **one month's written notice**. Tuition must be paid in full for the entire notice period, even if your child no longer attends during that notice period \_\_\_\_\_

**EARLY WITHDRAWAL FEE** A 10% fee will be assessed on any prepaid balance prior to Bloom issuing a refund on the balance \_\_\_\_\_

**FORFEIT OF PREPAID TUITION** Failure to provide written notice of intention to withdraw will result in the forfeiture of all prepaid tuition \_\_\_\_\_

**SUSPENDED ACCOUNT** If your account / enrollment has been suspended due to outstanding tuition fees, you

are required to pay the delinquent amount within 14 days. Failure to pay will result in your account being sent to a collection agency, and your enrollment in the Academy terminated \_\_\_\_\_

**NON-REFUNDABLE** Registration and Education Fees are not refundable \_\_\_\_\_

### **HOLIDAYS/ IN-SERVICE DAYS/ SCHOOL CLOSURES**

Tuition and fees are calculated on **an annual basis**, *without reduction* for holidays, vacations, and professional in-service days for our faculty, or absences or illnesses of students throughout the year. No credit or refund will be owed for school closures due to inclement weather, natural disasters, or pandemics. \_\_\_\_\_

**HOLIDAY BREAK** No tuition is charged for the Holiday Break in December. The **School Year** (Sept – June) annual tuition is calculated for 42 weeks. \_\_\_\_\_

**ADDITIONAL ENROLLMENT** Should you wish to extend your **School Year** enrollment into Summer Camp, please notify us in writing no later than May 15<sup>th</sup>. Enrollment is based on availability, and Summer tuition will be calculated at that time. \_\_\_\_\_

There is no additional Summer Registration Fee \_\_\_\_\_

**RETURNING STUDENTS** If your child is returning in September, and you have taken the summer off, the Annual Registration Fee will be due no later than March 1<sup>st</sup> in order to hold your child's spot \_\_\_\_\_

**ENROLLMENT FEES** The Registration Fee is due when your spot is confirmed and must accompany this form. Education Fees are due on the first day of your child's attendance, and every September thereafter. Enrollment fees are not pro-rated for year-round enrollment \_\_\_\_\_

**TUITION INCREASES** Tuition may be increased annually in September. You will receive written notification of any increases by April, along with an Amended Tuition Agreement to review and sign \_\_\_\_\_
